Services Over Sentences Grant Request for Proposal

The Office of Suffolk County District Attorney Kevin Hayden serves the cities and towns of Boston, Chelsea, Revere, and Winthrop, Massachusetts, handling more than 20,000 new criminal cases annually in nine district and municipal courts, the Suffolk County Superior Court, the Massachusetts Appeals Court, the Supreme Judicial Court, and the Boston Juvenile Court. As the top law enforcement official in Suffolk County, District Attorney Hayden strives to protect the safety and health of our communities and their residents. In pursuit of this goal, this office is committed to pursuing diversion, prevention and intervention efforts. We cannot do this work alone. We rely on, value and support the important work of community-based organizations that directly provide services to community members, including services to address trauma, violence, substance use disorder, mental health issues, and disparities in education.

Purpose

The Suffolk County District Attorneys Office (SCDAO) requests proposals to provide criminal court case-management and recovery support services for criminal defendants struggling with substance use disorders. These services are to be conducted in coordination with the existing Services over Sentences (SOS) program. The SOS program is designed to provide alternatives to traditional prosecution where appropriate. Specifically, SOS focuses on the following goals:

- Connect criminal court participants with substance use disorders to appropriate care and resources in the community.
- Offer treatment or recovery support services as an alternative to incarceration.
- Promote recovery, wellness and healthy lifestyles.
- Support individuals' accessibility to a continuum of care that includes rehabilitation services.
- Increase community safety and wellbeing by providing treatment and support to members of the community suffering from substance use disorder.

With funding through legislative budget appropriation and specialized grant sources, SCDAO can expand its Services over Sentences program to work involving increased case volume, with an intentional focus on dealing with substance use disorders, including a specialized effort as to the opioid epidemic which exists in the geographic area surrounding the intersection of Massachusetts Avenue and Melnea Cass Boulevard (Mass & Cass).

Project Scope

SCDAO will partner with community-based organizations to provide criminal court case assessment and management for voluntary participants with substance use disorders. All divisions of the Boston Municipal Court and Chelsea District Court will be serviced in any such partnership. The individuals at Mass & Cass are complex, high need, and high risk. There is not one region, discipline, municipality, or agency that will be successful in meeting the needs of this population. Enforcement alone will not be effective, nor will treatment and services alone. All arms of the criminal justice system and treatment providers must work in tandem towards a common philosophy and goal. The criminal legal system, working in tandem with treatment providers, can serve as an external motivator to improve engagement in treatment for individuals dwelling on Mass & Cass. In addition to SCDAO's existing partnership with North Suffolk Community Services (NSCS), SCDAO seeks partners with the internal capacity to provide a full array of supplementary services including case managers, recovery coaches, and clinicians.

SCDAO will fund the salary of approved positions working in tandem with SOS under this grant. Such positions would be considered an employee of the partner agency. Partner agencies will work with Assistant District Attorney's and Victim Witness Advocates, as well as a Services over Sentences coordinator from SCDAO, assigned to the courts to identify individuals who meet the SCDAO criteria for the Services over Sentences program. Partner agencies will have the additional responsibilities of providing evaluation and coordination of services, data collection and reporting requirements to SCDAO. To ensure that each case is individualized the partner agency would also be expected to make referrals to various agencies and services throughout Suffolk County as needed. The partner agency agrees that SCDAO will be an equal partner in the selection and hiring of positions acting as contractors with SCDAO through this grant.

Eligibility

SCDAO will be seeking a partner with the internal capacity to provide case managers, recovery coaches, clinicians and other treatment options. We will convene a subcommittee of community and internal volunteers to review and select the best partner agencies. The selected partner will meet the following requirements:

- Be a community-based agency within Suffolk County which includes the cities of Boston, Chelsea, Revere and Winthrop.
- Have extensive experience (more than five years) in providing services and referrals for substance use disorder and recovery.
- Provide In-house services including recovery coaches, case managers, licensed social workers or clinicians, and LADC certified counselors.

- Be an approved DMH or DPH provider.
- Demonstrate ability to serve diverse and multi-lingual populations and communities.

Timeline

- The RFP will be issued by October 12, 2023
- Proposals will be due by November 2, 2023
- Partnership announcements will be made in January 2024.
- Case manager should be assigned by end of January 2024.

Unallowable Use:

The following uses are not allowed:

- 1) Capital-building projects
- 2) Food
- 3) Lobbying
- 4) Religious purposes
- 5) Costs associated with fundraising activities
- 6) Bar charges or alcoholic beverages
- 7) Cash prizes or gift cards
- 8) Payment to other organizations in the form of donations or contributions
- 9) Legal work (advice or litigation)

Application Process:

Grant applications must be received no later than **5 p.m. on Thursday, November 2, 2023.** The applications will be reviewed by members of the District Attorney's staff to ensure that all required materials have been submitted. **Incomplete applications will not be considered.**

Selection And Criteria:

- 1. <u>Timeliness</u>- Applications must be received no later than **5 p.m. on Thursday, November 2, 2023.**
 - Applications received after the deadline will not be considered.
- 2. <u>Compliance</u> Applicants must provide all required information and documents. Incomplete applications or those requesting funds for non-allowable uses will not be considered. In the event an applicant requests funds for both allowable and non-allowable purposes, only the portion of the application requesting funds for allowable program expenses will be considered.
- 3. <u>Impact</u> The project addresses a goal, priority or concern within the target scope outlined in RFP.
